1. The Government of Papua New Guinea has received financing from the Asian Development Bank (ADB) toward the cost of **Power Sector Development Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Papua New Guinea Power Ltd** (PPL, “the Employer”) invites sealed bids from eligible Bidders for the **Design, Supply, Installation and Commissioning of Medium and Low Voltage Distribution Line and Household Connection Works for Ramu - Madang, Port Moresby and West New Britain Distribution Grids** (“the Facilities”).

Bidders may bid for any one or more combination of lots. Each lot will be evaluated and awarded separately.

3. **Open competitive bidding (international advertisement)** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

TenderLink portal before downloading the Bidding Documents. There is no charge for the Bidders to register themselves with the TenderLink portal and download the Bidding Documents.

Bidders may obtain further information by posting a query via the TenderLink portal, which will be provided to the eligible Bidders.

6. A pre-bid meeting will be held by video conference on 6 December 2022. Seven days before the pre-bid meeting, all registered Bidders will be given the video conferencing link to access and join the pre-bid meeting through TenderLink portal. Attendance is not mandatory but highly recommended.

7. Site inspections will be held on:

- Port Moresby Grid – 04 January 2023
- Ramu Madang – 06 January 2023
- West New Britain – 09 January 2023.

Attendance is not mandatory but very highly recommended.

- **on or before the deadline: 14:00 hours (local time), 20 February 2023**
- together with a Bid Security as described in the Bidding Document.

Late bids and hardcopy bid submissions will not be accepted. Technical Bids will be opened electronically on the TenderLink portal immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.
